SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

General advice

Consult a physician. Show this safety data sheet to the doctor in attendance. Move out of dangerous area.

If inhaled

Remove person to fresh air and keep comfortable for breathing. Call a poison center or doctor if you feel unwell. Acute and delayed symptoms and effects: May cause respiratory irritation. Signs/symptoms may include coughing.

In case of skin contact

Take off immediately all contaminated clothing. Rinse skin with water/shower for at least 15 minutes. Call a poison center or doctor if irritation develops or persists. 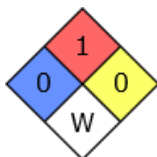
